Avetta will help make this transition in SUEZ' EHS management process as seamless as possible while providing valuable services and benefits. The registration period is from **Friday, May 5<sup>th</sup>, 2017** to **Monday, August 7<sup>th</sup>, 2017**.

All contractors and suppliers who wish to continue qualifying for ongoing projects and bid opportunities with SUEZ must be registered with Avetta by the timeline established below.

#### Step 2 - Required by Wednesday, July 5th, 2017:

✓ Prequalify to work with SUEZ as detailed in the Avetta system



# Step 3 - Required by Monday, August 7<sup>th</sup>, 2017:

✓ Achieve "Complete" status as detailed in the Avetta system
