



### Register for the Amazon UK Vendor Management Program

At Amazon we are currently on a path towards being a safety-first company. As an active supplier we greatly value our relationship with you, and we are always looking for ways to simplify our processes and work towards being the safest employer in the world.

For this reason, we have implemented an online Supplier prequalification and management program. This will eliminate our individual site level prequalification process to make the supplier experience better for everyone.

This program applies to all vendors who provide on-site services at Amazon owned or leased property. We have identified your company, as an active supplier to be included in this program. Please follow the steps below to register, and submit your company, in order to be compliant with Amazon's prequalification requirements. There may be a fee that will be due upon registration that is based upon number of employees and other factors.

### <u>Three Steps to "Compliant" Status</u> (Please have all steps completed by January 31<sup>st</sup>, 2023)

### Step 1:

✓ Register by using the link below (if you are already active in Avetta, the connection to Amazon UK will be added for you)

# Please note, you will need to connect to the site named 'Amazon UK Supplier' when creating and registering your account

### Step 2:

✓ Submit all Amazon required company information, safety metrics, safety procedures, and insurance information into the system as part of Avetta's prequalification process. Avetta will then perform a review and verification of your information and work with you to become complaint for Amazon.

# Please note that the review time frame for an audit is <u>10 working days</u> and insurance is <u>2 working days</u>. We recommend you submit all your documentation with enough time for verification.

### Step 3:

✓ You must either be compliant or have an approved variance in the system in order to be in compliance with Amazon requirements.

# Any supplier who does not reach a registered and compliant status by January 31<sup>st</sup>, 2023 will be subject to Amazon review and receiving future works
