Use Cases	Description

Business Analytics	Feed Avetta compliance data into internal dashboards and reporting tools.
Company Compliance	Sync compliance statuses to internal systems to block purchases or POs for non-compliant suppliers.
Worker Knowledge	Sync worker records with learning management systems to track ongoing education.
Site Access	Send worker compliance status to time/attendance or access control systems to prevent unqualified workers from entering job sites.

Integration Timelines
