

Supplier Safety Prequalification Program

Dear Valued Entergy Supplier:

As an Entergy supplier, you have been identified to participate in Entergy's Supplier Safety Prequalification Program. This program is vital to ensure a safe workplace for Entergy employees, suppliers, and customers and will be hosted by our third-party partner, Avetta.

Enrollment in this program is **required** to prequalify as a new service provider or to obtain qualification status as a current provider for Entergy. Qualification does not guarantee that you will be awarded work at Entergy; however, it does ensure that your company will be considered for work at Entergy sites/locations in the future.

As you prequalify or maintain your current status for Entergy, Avetta will help to make this transition as seamless as possible while providing invaluable services and benefits to all of Entergy's suppliers. The enclosed communication will guide you through the Avetta registration process. It will also direct you to helpful resources should you have any questions.



Registration / Prequalification Requirements

Registration Deadline March 20, 2020

- Register Online Each service supplier and subcontractor must register on the Entergy Nuclear's Avetta portal at http://pages.avetta.com/Entergy.html and click on Join Avetta. If you are already an Avetta member, simply log into your account and link your company with Entergy. Avetta representatives will be available to provide registration assistance by phone at 800-506-7427 Opt. 2
- **Complete the Service Evaluation:** Provide basic information to Avetta about the services your company performs.
- Select Membership Term: Select either a one, two, or three-year term for membership. Twoyear memberships will receive a 5% discount. Three-year memberships will receive a 10% discount.
- **Complete the Prequalification Form:** Begin the qualification process by completing and submitting the PQF and annual update information online.
- **Upload Your Documentation:** Even if you have already provided Entergy with a copy of your W-9 and OSHA logs, etc., please upload your current documentation on the Avetta website.
- **Respond to any Audit Questions:** After submitting your PQF and required documentation online, an Avetta representative will contact you to review your submission. Your dedicated Avetta representative will work with you to collect missing information to ensure you achieve completed status for Entergy.
- **Complete Status:** Once you have achieved complete status, your company will be rated as compliant in Avetta Organizer and available for contract work with Entergy and other clients within the exclusive Avetta network, which you can ask Avetta about.

Membership Fee (Excludes Profiles Accounts)

For partners that are not already active in the Avetta supplier ecosystem, there is a one-time registration fee of **\$299**. In addition to the registration fee, there is an annual membership fee based upon the number of client connections where services are provided. The complete fee structure is available on the Avetta website and can be reviewed during the registration phase.

Benefits of Avetta Membership

- **Exposure**—Once registered in the Avetta system, suppliers can search for additional business opportunities in the system. Your company and all your services will be readily available to large organizations that are a part of the Avetta network.

What is a supplier required to do if already a member of Avetta?

If your company is already a registered member with Avetta, you must log into your existing account to ensure your company information is up to date. Then select Entergy as the client/facility where you work. There may be an additional fee to select Entergy as a client depending upon the number of sites where you provide products or services.
